3) In the meeting the Deputy Director (Addl.Charge) of Geology and Mining/ Convener has pointed out the activities of the DMFT Trust of Chengalpattu District which is well functioning and funds are being collected under DMFT as per rule. Further, as on 31.12.2024 an amount of Rs.4.96 crores is available for sanction of new projects.

4) Among the projects sanctioned earlier during the year 2020-2021, 2021-2022, 2022-2023 the implementing agencies have completed 19 projects.

5) In the meeting the appointment of DMFT auditor Tvl.Sundarajan & Co., for the period of three years from 15.09.2024 to 14.09.2027 vide District Collector's Proceedings in Rc.262/Mines/2024 Dt.22.11.2024 and appointment of Accountant for the period from 01.05.2024 to 31.03.2025 vide District Collector Proceedings in Rc.262/Mines/2024 Dt.21.05.2024 have also been approved by the Governing Council as per the recommendation of Managing Committee.

6) In the meeting the DMFT audit report for the period 2022-2023, 2023-2024, Annual budget and Annual Plan for the period 2023-2024, have

also been approved by the the Governing Council as per the recommendation of Managing Committee.

7) In the meeting administrative sanction an amount of Rs.9,90,000/- was sanctioned to the Deputy Director of Health Services, Chengalpattu District for the project of 5 No's of Ice Line Refrigerator for storage of Immunization Vaccines in PHCs catering mine affected villages vide Rc.No.53/Mines/2023, dated: 03.05.2023 has also been approved by the Governing Council as per the recommendation of Managing Committee.

8) In the meeting administrative sanction an amount of Rs.17,00,000/- was sanctioned to the Dean, Chengalpattu Medical College, Chengalpattu District for providing the Phacoemulsification Machine for doing cataract surgery to treat cataract patients and to train the students adequately as per NMC Norms in Chengalpattu district vide Rc.No.53/Mines/2023, dated.17.02.2024 has also been approved by the Governing Council as per the recommendation of Managing Committee.

9) In the meeting administrative sanction an amount of Rs.22,96,000/- was sanctioned to the Dean, Chengalpattu Medical College, Chengalpattu District for New Arthroscopy set and instruments with monitor for effective functioning including sports injury clinic in Chengalpattu Medical College Hospital vide Rc.No.53/Mines/2023, dated.02.03.2024 has also been approved by the Governing Council as per the recommendation of Managing Committee.

10) In the meeting administrative sanction an amount of Rs.3,49,000/- was sanctioned to the Chairperson of DMFT / District Collector Chengalpattu District ^{to procure 1-Pad} for efficient implementation and monitoring of the District Mineral Foundation Trust works vide Rc.No.53/Mines/2023, dated: 15.03.2024 has also been approved by the Governing Council as per the recommendation of Managing Committee.

11) The District Collector has also instructed the implementing agencies to submit detailed project report for new projects by giving top most priority for the construction of additional building for Schools, New Anganwadi buildings and Over Head Tanks etc.,

12) The list of 50 Directly & 20 Indirectly Mine affected villages as of December 2024 has already been uploaded in the PMKKKY portal. Further, 39 villages have been added as mine affected villages and also been approved by the Governing Council as per the recommendation of Managing Committee. Hence, a total of 109 Directly and Indirectly mine affected villages as listed to be considered for future development works (Annexure).


